NEED-BASED SCHOLARSHIP AWARDS **RULES AND REGULATIONS FOR 2010-2011**

1. Scholarships are awarded without restriction as to academic discipline or course of study to qualifying full-time students having Freshman, Sophomore, Junior or Senior status in the forthcoming academic year for first bachelor degree. An applicant, if judged an awardee, may still be eligible when transferring to another acceptable institution where there is no Phi Kappa Sigma chapter.
2. To be eligible, an applicant must be an officially registered member of Phi Kappa Sigma Fraternity with his initiation fee having been remitted by his chapter to the Fraternity Headquarters. Graduate students are not eligible. Previous award winners are eligible if qualified, as long as their undergraduate status remains, including five year Bachelor degree programs.
3. The number and amount of scholarship awards are determined annually by the Board of Trustees of the Foundation. This year scholarships totaling **\$60,000, with awards ranging up to \$5,000** each have been authorized. **Applicants are eligible for BOTH NEED-BASED AND PARTICIPATION-BASED AWARDS** upon submittal of each corresponding application.
4. The weighted criteria for judging **NEED-BASED applications are Financial Need 50% and Scholastic Achievement 50%**. The awards decisions are composites of rankings made independently by members of the Scholarship Awards Committee.
5. Copies of the application are sent to each chapter Alpha for distribution to members of the chapter. Additional copies if needed may be obtained from the ΦΚΣ web site: <http://www.pks.org>)
6. Applications must be FULLY LEGIBLE. TYPED OR WORD PROCESSED IS HIGHLY RECOMMENDED. A 2010-2011 standard application form as distributed by the Foundation must be used. Previous year's application form is not valid.
7. Other information which you feel would be of assistance to the Awards Committee may be given on an additional sheet.
8. **Official transcript of grades must** be forwarded directly to the listed address of Jeff Long the Chairman of the Scholarship Awards Committee by the college registrar (allow two weeks). It is applicant's responsibility to assure that transcript has been forwarded, postmarked on or before April 1, 2010.
9. Your 2008 Federal Income Tax return 1040, Pages 1 and 2 only, 1040A or 1040EZ for applicant and each parent, FAFSA or SAR, **ARE NOT REQUIRED, BUT HIGHLY RECOMMENDED to further your Need-Based Award consideration.** Updated copies are acceptable until March 31.
10. Your Chapter Advisor must submit the **CHAPTER ADVISOR CHECK-OFF form.**
11. Application must be complete in every detail. **All information must reach scholarship@pks.org or the Chairman of the Scholarship Awards Committee postmarked no later than April 1, 2008. Electronic application submissions are accepted.**
12. After ratings have been consolidated, the Committee Chairman will submit rankings thereof to the President of the Foundation.
13. The Foundation President will notify all successful applicants of award decision on or about May 31.
